CONSERVATION FORCE

IMPORT OF ELEPHANTS FROM ZIMBABWE & ZAMBIA

Two and three-year positive enhancement findings made for elephant in November 2017 and, for lion, in October 2017, in respect of Zimbabwe and Zambia, have been withdrawn by the United

States Fish and Wildlife Service (USFWS).

The reason for this is that the court found in the Safari Club International (SCI)/National Rifle Association (NRA) case that the procedure was not lawful. Secondly, President Trump has ordered a hold on all elephant imports. Elephant import permits for Zimbabwe, Zambia, RSA and Namibia are not being issued at this time and, if and when they are issued again, it will be application by application, without countrywide determinations made one, two, or three years in advance.

Perhaps more relevant, the positive, countrywide enhancement determinations for South Africa for wild lion, elephant and bontebok have been withdrawn by USFWS and have to be remade after the district court final judgment in the SCI/NRA case, expected sometime within the next month. The USFWS expects to start remaking enhancement findings application by application, instead of one to three years in advance, but not for elephant because Trump has a hold on elephant.

The last round of legal briefs in the SCI/NRA case are due soon. Then we wait on the judge, but the USFWS withdrew the countrywide, prospective determinations at the time of the first round of briefings to show compliance and because the anti-hunters have filed suits to enforce the SCI/NRA case against the hunting community.

The new procedure is not hunting site by hunting site, though site information is welcome and helpful and may even become necessary.

Application by application means the enhancement is limited to a single hunt at a certain point in time, rather than a sweeping, countrywide determination that is prospective, which the court has held requires a full rule-making procedure (the federal register publication of a proposal with a public comment period for a minimum of 30 days, and republication of the final determination that addresses all the substantive issues raised in the comments and explains the full rationale of the final determination, followed by a 30-day wait before it is made effective).

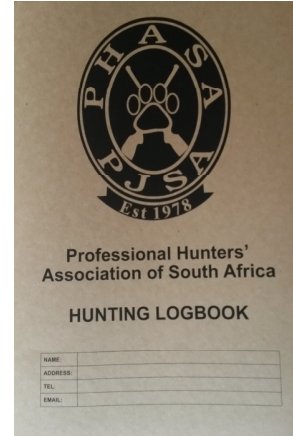
